4. If your insurance provider repudiates your motor vehicle insurance claim subsequent to you being provided with a rental vehicle, all car hire costs will be for your own account, and you will be required to reimburse us accordingly for any amounts that we may have paid for hiring the vehicle;
5. If your insured vehicle is not repaired within the maximum days permitted, you will be offered the option to continue renting on your own account indefinitely at discounted rates. (Upfront payment is required).
6. The rental vehicle provided will be a vehicle in the vehicle group selected and for which premiums have been paid. If restrictions on your license prohibit you from legally driving a vehicle in the group selected, or you require an upgrade, this can be arranged directly with us. Charges for upgrades whether by law, or elected will be for your account. (Upfront payment is required).
7. The rental vehicle will be provided by the car rental supplier appointed by us. Should you rent directly from a car rental company, we will only reimburse you the amount had car rental been arranged by us.
8. You must sign all documentation required by the nominated car rental supplier, and pay the required car rental deposit (fuel deposit) in cash or via credit card at the time of deliver or collection of the rental vehicle.
9. The terms and conditions of the nominated car rental supplier, a copy of which will be provided to you at the time of delivery / collection of the rental vehicle shall apply, and you are advised to familiarise yourself with same.
10. The rental vehicle may only be driven by the person/s nominated and be in possession of a valid, unendorsed driver's license, as agree with the car rental supplier.
11. The rental vehicle may not be driven beyond the borders of the Republic of South Africa, unless authorised by the car rental supplier in writing beforehand.
